#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO LIXSOURCE TRADING FOR THE SUPPLY & DELIVERY OF DRUGS AND MEDICINES FOR CHU STOCKFILING OF MEDICINES FOR EMERGENCY PREPAREDNESS

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-04-0506** with an Approved Budget for the Contract (ABC) of **Php 98,903.00**;

**WHEREAS**, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

**WHEREAS**, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:

**WHEREAS**, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, Nasakiah Trading, it was found non-compliant with the requirements of the project particularly failure to indicate the brand of the items offered and to submit the required CPR & CGMP; Hence, its bid was disqualified.

**WHEREAS**, the BAC proceeded with the examination, validation, and verification of all the documents submitted by Lixsource Trading, the supplier with the second lowest quoted price, and it was found to be responsive with the requirements of the project;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To award the contract to **Lixsource Trading** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b) To recommend to the City Mayor of Tabaco the award of contract to **Lixsource Trading** in the amount of **Ninety-Eight Thousand Six Hundred Thirty-Five Pesos and Seventy-Five Centavos (Php 98,635.75)**.
