### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES AND GENERAL MDSE. FOR THE SUPPLY & DELIVERY OF DRUGS AND MEDICINES FOR SEXUAL REPRODUCTIVE HEALTH CAMPAIGN

**WHEREAS**, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


