**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO RRS MARKETING CORPORATION FOR THE SUPPLY & DELIVERY OF AIRCONDITIONING SYSTEM FOR PDA OFFICE**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-04-0533** with an Approved Budget for the Contract (ABC) of **Php 95,000.00**;
