**WHEREAS**, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:




**WHEREAS**, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;
