**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KRMKA GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF VARIOUS CHEMICALS FOR OPERATION AND MAINTENANCE, ODOR NEUTRALIZATION AND WATER PURIFICATION AT WASTEWATER TREATMENT FACILITY, CENTRAL MRF AND SANITARY LANDFILL**


**WHEREAS**, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;
