A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JYQ ENTERPRISES FOR THE JO-LABOR & MATERIALS FOR THE BODY REPAIR OF RESCUE VEHICLE WITH PLATE NO. SAB-6278 (RV2)

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a) To award the contract to **JYQ Enterprises** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
