A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO J.R. FURNITURE SHOP FOR THE SUPPLY & DELIVERY OF WOODEN OFFICE TABLE WITH CHAIR AND CABINET FOR MCK OFFICE
