A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR FOR THE SUPPLY & DELIVERY OF VARIOUS PRINTERS FOR VARIOUS OFFICES

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-05-0607** with an Approved Budget for the Contract (ABC) of **Php 267,000.00**;
