BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO ST. MARY'S PUBLISHING CORPORATION FOR THE SUPPLY & DELIVERY OF SUPPLEMENTARY INSTRUCTIONAL MATERIALS FOR GRADE 7, SDO-TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) has adopted **Direct Contracting** as the mode of procurement for the **Supply & Delivery of Supplementary Instructional Materials for Grade 7, SDO-Tabaco City** under Purchase Request No. **25-05-0639** with an Approved Budget for the Contract (ABC) amounting to **One Million Four Hundred Ninety-Nine Thousand Five Hundred Twenty Pesos (Php 1,499,520.00)**;


WHEREAS, the BAC directly negotiated the foregoing project with **St. Mary's Publishing Corporation** by requesting the same to submit a price quotation or pro-forma invoice together with the terms and conditions of the sale;

WHEREAS, after the deadline for submission of price quotation, **St. Mary's Publishing Corporation** has offered to supply and deliver the goods at a contract price of **One Million Four Hundred Ninety-Nine Thousand Five Hundred Twenty Pesos (Php 1,499,520.00)**;

WHEREAS, upon careful examination, validation, and verification of all the documents submitted by **St. Mary's Publishing Corporation** the BAC found that it is technically, legally and financially capable to deliver the goods and the price offered is the most advantageous price for the government;


NOW, THEREFORE, in the light of the foregoing considerations, We, the members of the Bids and Award Committee, hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend for approval by the City Mayor, **CIELO KRISSEL BURCE LAGMAN**, the award of the foregoing contract to **St. Mary's Publishing Corporation** at a contract price amounting to **One Million Four Hundred Ninety-Nine Thousand Five Hundred Twenty Pesos (Php 1,499,520.00)**;
