A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT AND CONSTRUCTION FOR THE JO-LABOR, MATERIALS FOR THE INSTALLATION/IMPROVEMENT OF WATER SUPPLY SYSTEM AT BRGY. SAN VICENTE, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-05-0642** with an Approved Budget for the Contract (ABC) of **Php 500,000.00**;
