A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO IULEKZ AGRI INPUTS MARKETING FOR THE SUPPLY & DELIVERY OF FERTILIZER FOR CORN CLUSTERED ASSOCIATION
