A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO YSSA'S BOTANICAL GARDEN FOR THE SUPPLY & DELIVERY OF AGOHO SEEDLINGS FOR TREE PLANTING ACTIVITIES AT CENTRAL MRF FOR RESILIENCY MONTH

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-05-0665** with an Approved Budget for the Contract (ABC) of **Php 333,900.00**;
