A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE JO-LABOR & MATERIALS FOR THE F1C-028 (AMBULANCE), SNA-5335 (DUMP TRUCK), GENERATOR SET AND JM-4520 (DROPSIDE TRUCK)
