A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VARIOUS VEHICLE PARTS AND ACCESSORIES FOR NGF-3062, SEH-610, F4J-884 (AMBULANCE) AND S5W-694 (PTV)
