### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MANZIHING CORPORATION FOR THE SUPPLY & DELIVERY OF VARIOUS VEGETABLE SEEDS FOR GULAYAN SA NATAD PROGRAM

**WHEREAS**, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:



**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


- To award the contract to **Manzihing Corporation** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.


