A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO R. BOLA'S NATIVE PRODUCTS STORE FOR THE SUPPLY & DELIVERY OF NATIVE BAG WITH SINAMAY TO BE GIVEN AS TOKEN FOR TABAK FESTIVAL 2025 GUESTS AND ARTISTS

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-06-0715** with an Approved Budget for the Contract (ABC) of **Php 100,000.00**;
