#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DISTRICT MUSIC CAFE DINER AND CATERING SERVICES FOR THE SNACKS FOR OPENING PROGRAM OF TABAK FESTIVAL 2025

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-06-0717** with an Approved Budget for the Contract (ABC) of **Php 168,750.00**;
