A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO RDJ MULTIMEDIA SOLUTIONS FOR THE PHOTO AND VIDEO COVERAGE OF THE ROSTER ACTIVITIES/EVENTS OF TABAK FESTIVAL 2025

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-06-0722** with an Approved Budget for the Contract (ABC) of **Php 250,000.00**;
