**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO PATIO DE SAN JOSE RESORT & CONVENTION CENTER INC. FOR THE HOTEL AND MEALS FOR GUESTS ARTISTS/PERFORMERS FOR 24TH TABAK FESTIVAL 2025**
