A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DISTRICT MUSIC CAFE DINER AND CATERING SERVICES FOR THE MEALS FOR THE LGU NIGHT (TABAK FESTIVAL 2025)
