### BAC Resolution No. PB-2025-09-0001

**A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO BCVR PRIME ENTERPRISE FOR THE SUPPLY AND DELIVERY OF CANNED GOODS FOR DISASTER PREPAREDNESS (STOCKPILING OF GOODS), MO-CDRRMO, TABACO CITY UNDER CONTRACT ID NO. 001-08-2025-GOODS-PB**

**WHEREAS** the City Government of Tabaco posted the Invitation to Bid for the *Supply and Delivery of Canned Goods for Disaster Preparedness (Stockpiling of Goods), MO-CDRRMO, Tabaco City under Contract Id No. 001-08-2025-GOODS-PB with an Approved Budget Contract (ABC) of Nine Hundred Eighty Two Thousand Four Pesos (Php982,004.00)*, in the PhilGEPS website, Tabaco City website, and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

**WHEREAS**, in response to the said posting, one (1) supplier had shown interest in participating in purchasing the bidding documents;

**WHEREAS**, during the deadline for submission and the opening of bids on August 20, 2025, the BAC received one (1) bid proposal;

**WHEREAS**, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

**WHEREAS**, the BAC immediately conducted the detailed evaluation and comprehensive assessment of the bid, which resulted as follows, to wit:

**WHEREAS** the BAC Technical Working Group (TWG) conducted a post-qualification of *BCVR Prime Enterprise*, the bidder with single calculated bid, involving the analysis, verification, and validation of its legal, technical, and financial documents. It was found that *BCVR Prime Enterprise* is substantially compliant with the requirements of the foregoing procurement, and its bid is responsive;

**NOW, THEREFORE**, in the light of the foregoing considerations, we, the members of the Bids and Award Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) to declare the **BCVR Prime Enterprise's** bid as the Single Calculated Responsive Bid (SCRB) for the **Supply and Delivery of Canned Goods for Disaster Preparedness (Stockpiling of Goods), MO-CDRRMO, Tabaco City under Contract Id No. 001-08-2025-GOODS-PB**, and;
- b) to recommend to the City Mayor of Tabaco the award of contract to BCVR Prime Enterprise in the amount of **Eight Hundred Seventy-Five Thousand Nine Hundred Ten Pesos (Php875,910.00)**.
