BAC Resolution No. 2025-1Q-02- 0022

A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO LEGAZPI PREMIUM DEVELOPMENT CORPORATION FOR THE SUPPLY, DELIVERY & INSTALLATION OF AIRCONDITIONING UNITS AT LEGISLATIVE BUILDING, KARANGAHAN BOULEVARD, TABACO CITY UNDER CONTRACT ID NO. 004-01-2025-GOODS-PB

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply, Delivery & Installation of Airconditioning Units at Legislative Building, Karangahan Boulevard, Tabaco City under Contract ID No. 004-01-2025-GOODS-PB*, with an Approved Budget for the Contract (ABC) amounting to *Three Million Pesos (Php 3,000,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) suppliers had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on February 05, 2025, the BAC received two (2) bids proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

The bid of the other bidder, Macro-Aire Refrigeration & Airconditioning Center, was rated “Failed” in the Technical Component for failure to submit and comply the required documents.

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:

WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *Legazpi Premium Development Corporation*, the bidder with single calculated bid, involving the verification and validation of its legal, technical and financial documents. It was found that *Legazpi Premium Development Corporation* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- To declare the bid of **LEGAZPI PREMIUM DEVELOPMENT CORPORATION** as the Single Calculated Responsive Bid (SCRB) for the *Supply, Delivery & Installation of Airconditioning Units, Legislative Building, Karangahan Boulevard Tabaco City under Contract ID No. 004-01-2025-GOODS-PB*; and

- b) To recommend to the City Mayor of Tabaco the award of contract to **LEGAZPI PREMIUM DEVELOPMENT CORPORATION** in the amount of **Two Million Nine Hundred Sixty-Eight Thousand Pesos (Php 2,968,000.00)**.

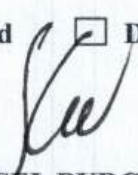
