A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES AND GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF DRUGS & MEDICINES, CHU AND FWK, TABACO CITY UNDER CONTRACT ID NO. 016-03-2025-GOODS-PB

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Drugs & Medicines, CHU and FWK, Tabaco City under Contract ID No. 016-03-2025-GOODS-PB*, with an Approved Budget for the Contract (ABC) amounting to *Three Million Fifty-Nine Thousand One Hundred Forty-One Pesos and Fifty-Five Centavos (Php 3,059,141.55)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on April 14, 2025, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:

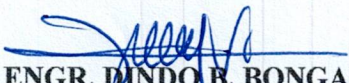

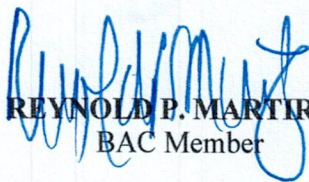
WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *MGM Medical Supplies and General Merchandise*, the bidder with single calculated bid, involving the verification and validation of its legal, technical and financial documents. It was found that *MGM Medical Supplies and General Merchandise* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- To declare the bid of *MGM Medical Supplies and General Merchandise* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Drugs & Medicines CHU and FWK, Tabaco City under Contract ID No. 016-03-2025-GOODS-PB*; and
- To recommend to the City Mayor of Tabaco the award of contract to *MGM Medical Supplies and General Merchandise* in the amount of *Two Million Nine Hundred Thousand Thirty Pesos and Seventy-Two Centavos (Php 2,900,030.72)*.

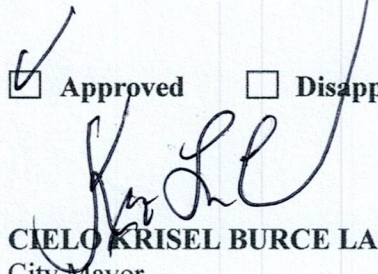
