A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION & SUPPLY FOR THE JO-LABOR, EQUIPMENT RENTAL AND MATERIALS FOR THE OPERATION AND MAINTENANCE OF FARM TO MARKET ROAD (HACIENDA TO VISITA SECTION) AT SAN MIGUEL ISLAND, TABACO CITY

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

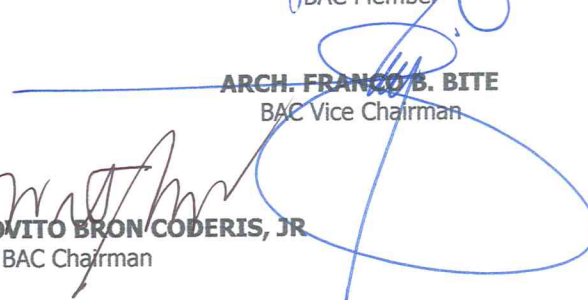
