A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO NOSOL TIRE SUPPLY FOR THE SUPPLY & DELIVERY OF VEHICLE TIRE FOR LOVE BUS WITH CONDUCTION STICKER JOA-826

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Small Value Procurement under Section 53.9 of the IRR-RA 9184 as the mode of procurement for Purchase Request No. 25-03-0447 with an Approved Budget for the Contract (ABC) of Php 150,000.00;
