A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE VEHICLE PARTS AND ACCESSORIES FOR FILTERS, AIR FRESHENER AND WIPER BLADE FOR VARIOUS TRANSPORTATION EQUIPMENT AND HEAVY EQUIPMENT

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-03-0448** with an Approved Budget for the Contract (ABC) of **Php 120,564.40**;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:

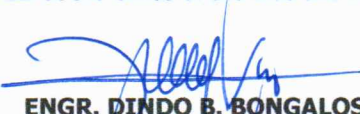

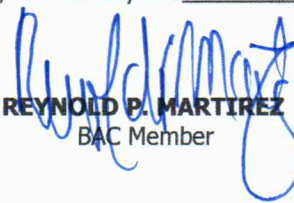
WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;
