A RESOLUTION RECOMMENDING THE HOPE TO DECLARE FAILURE OF BIDDING FOR THE SUPPLY AND INSTALLATION OF LED WALL, MO-CDRRMO, TABACO CITY UNDER CONTRACT ID NO. 010-09-2025-GOODS-PB-LED WALL

WHEREAS the City Government of Tabaco posted the Invitation to Bid for the *Supply and Installation of LED Wall, MO-CDRRMO, Tabaco City under Contract ID No. 010-09-2025-GOODS-PB-LED Wall with an Approved Budget Contract (ABC) of One Million Eight Hundred Thousand Pesos and 00/100 (Php1,800,000.00)*, in the PhilGEPS website, Tabaco City website, and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, the Pre-Bid Conference for the forgoing project was held one (1) day earlier prior to the completion of the seven (7) calendar days from the PhilGEPS posting of the Invitation to Bid or Bidding Documents with the following details to wit:

Invitation to Bid Clause No. 6: The City Government of Tabaco will hold a Pre-Bid Conference on 10 October 2025, 2:00 PM at BAC Conference Room, Mezz Floor, City Legal Office, 2F Annex Building, Tabaco City Hall, Tabaco City, which shall be open to prospective bidders.

PhilGEPS Posting Reference No. 12455375 dated 04 October 2025

WHEREAS, the Bids and Awards Committee found out to have failed the prescribed bidding procedures under Section 22.2 of the 2016 Revised IRR-RA9184 provides that the pre-bid conference shall be held at least twelve (12) calendar days before the deadline for the submission and receipt of bids, *but not earlier than seven (7) calendar days from the PhilGEPS posting of the Invitation to Bid or Bidding Documents* and in the case of Consulting Services, from the determination of the shortlisted consultants. If the Procuring Entity determines that, by reason of the method, nature, or complexity of the contract to be bid or when international participation will be more advantageous to the GoP, a longer period for the preparation of bids is necessary, the pre-bid conference shall be held at least thirty (30) calendar days before the deadline for the submission and receipt of bids;

WHEREAS, Section 41 (b): Reservation Clause, the HoPE reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract if the BAC is found to have failed in following the prescribed bidding procedures;

NOW THEREFORE, for and in consideration of the foregoing, we, the members of the Bids and Awards Committee, hereby **RECOMMEND** to the Head of Procuring Entity to declare **FAILURE OF BIDDING for the Supply and Installation of LED Wall, MO-CDRRMO, Tabaco City under Contract ID No. 010-09-2025-GOODS-PB-LED Wall;**

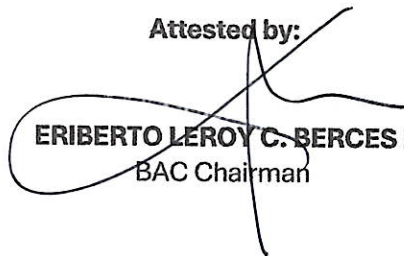

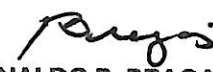
