## BAC Resolution No. PB-2025-10-0007

A RESOLUTION DECLARING FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF ONE-UNIT BRAND-NEW EMERGENCY/RESCUE VEHICLE, MO-CDRRMO, TABACO CITY, UNDER CONTRACT ID NO. 005-09-2025-GOODS-PB-EMERGENCY/RESCUE VEHICLE

WHEREAS the City Government of Tabaco posted the Invitation to Bid for the Supply and Delivery of One-Unit Brand-New Emergency/Rescue Vehicle, MO-CDRRMO, Tabaco City, under Contract ID No. 005-09-2025-GOODS-PB-Emergency/Rescue Vehicle with an Approved Budget Contract (ABC) of Two Million Five Hundred Thousand Pesos (Php2,500,000.00), in the PhilGEPS website, Tabaco City website, and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest in participating in purchasing the bidding documents;

**WHEREAS,** Section 35.1 (b) of the 2016 Revised IRR-RA9184 provides that the BAC shall declare failure of bidding when all prospective bidders are declared ineligible;

WHEREAS, Rule VIII Receipt and Opening Of Bids, Section 23.1(a) Class A Documents – Legal Documents: For purposes of determining the eligibility of bidders using the criteria stated in Section 23.4 of this IRR, only the following documents shall be required by the BAC, using the forms prescribed in the Bidding Documents and for the purpose of updating the Certificate of PhilGEPS Registration (Platinum Membership) pursuant to Section 8.5.2 of the Revised IRR of Republic Act No. 9184, all Class "A" eligibility documents covered supporting the veracity, authenticity, and validity of the same shall remain current and updated. The failure by the prospective bidder to update this certificate with the current and updated Class "A" eligibility documents shall result in the automatic suspension of its validity until such time that all of the expired Class "A" eligibility documents has been updated.

**WHEREAS**, during the opening of the Bids under the Technical Component - Conformity with the Technical Specifications, which include:

- i. Production / Delivery Schedule **60 calendar days versus the required 45 calendar days**, *and*
- ii. If there is a third-party supplier, all these requirements must be complied: Certificate of availability of service center in Bicol Region, Agreement / Certification issued by the partner service center that it will cater to the after-sales service/parts of the unit offered by the bidder No attached Service Center within Bicol Region / Agreement with the Service Center (being a trading company);

NOW THEREFORE, for and in consideration of the foregoing, we, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare FAILURE OF BIDDING for the Supply and Delivery of One-Unit Brand-New Emergency/Rescue Vehicle, MO-CDRRMO, Tabaco City, under Contract ID No. 005-09-2025-GOODS-PB-Emergency/Rescue Vehicle;

**RESOLVED FURTHER**, to repost the bidding opportunity on the PhilGEPS website, Tabaco City website and in three conspicuous places within the premises of the city, for the rebidding of the foregoing project.
