A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO JOUIR GENERAL MERCHANDISE FOR THE SUPPLY AND DELIVERY OF PAMASKONG HANDOG PACK, CITY MAYOR'S OFFICE, TABACO CITY, UNDER CONTRACT ID NO. 008-09-2025-GOODS-PB-PAMASKONG HANDOG

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply and Delivery of Pamaskong Handog Pack, City Mayor's Office, Tabaco City, under Contract ID No. 008-09-2025-GOODS-PB-Pamaskong Handog* with an Approved Budget for the Contract (ABC) amounting to *Twenty Eight Million Two Hundred Thousand (Php28,200,000.00)* in the PhilGEPs website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier has shown interest in participating in purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on 14 October 2025, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which was rated Passed, and the result was as follows, to wit:

WHEREAS, the BAC Technical Working Group (TWG) conducted the post-qualification of **JOUIR GENERAL MERCHANDISE**, the bidder with lowest calculated bid, involving the verification and validation of its legal, technical and financial documents. It was found that **JOUIR GENERAL MERCHANDISE** is substantially compliant with the requirements of the foregoing procurement, and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, we, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of **JOUIR GENERAL MERCHANDISE** as the Lowest Calculated Responsive Bid (LCRB) for the **Supply and Delivery of Pamaskong Handog Pack, City Mayor's Office, Tabaco City, under Contract ID No. 008-09-2025-GOODS-PB-Pamaskong Handog**; and
- b) To recommend to the City Mayor of Tabaco the award of contract to **JOUIR GENERAL MERCHANDISE** in the amount of **Twenty-Eight Million Fifty-Nine Thousand Pesos and 00/100 (Php28,059,000.00)**.
