A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ARAL LAMPARA AT MUSIKA SOUND SYSTEM SERVICES FOR THE RENTAL OF SOUND SYSTEM WITH LED WALL, ARCH TENT AND LIGHTS FOR THE TABACO CITY ANNIVERSARY 2026

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-02-0004** with an Approved Budget for the Contract (ABC) of **Php 350,000.00**
