A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO PAPER-TECH PRINTING SHOP FOR THE SUPPLY AND DELIVERY OF T-SHIRTS WITH PRINT FOR THE TABACO CITY ANNIVERSARY 2026

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-02-0010** with an Approved Budget for the Contract (ABC) of **Php 599,840.00**
