**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JOAQUINS NON- SPECIALIZED WHOLESALE TRADING FOR THE SUPPLY AND DELIVERY OF VARIOUS JANITORIAL SUPPLIES FOR GSO USE**

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-02-0021** with an Approved Budget for the Contract (ABC) of **Php 372,035.00**

WHEREAS, the BAC has posted in the PHILGEPS website the Request for Quotation for this procurement and sent to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;
