A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JOUIR GENERAL MERCHANDISE FOR THE SUPPLY AND DELIVERY OF CUSTOMIZED SPORTS UNIFORM FOR PALARONG BICOL 2026

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA 12009 as the mode of procurement for **Purchase Request No. 2025-02-0046** with an Approved Budget for the Contract (ABC) of **Php 1,145,000.00**;
