A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE SUPPLY AND DELIVERY OF AIRCON MAINTENANCE TOOLS & SUPPLIES

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-02-0078** with an Approved Budget for the Contract (ABC) of **Php 224,619.00**
