#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO PURE GREEN SOLUTION TECHNOLOGY INC. FOR THE SUPPLY & DELIVERY OF CHEMICALS FOR THE WASTEWATER TREATMENT FACILITY AT CITY ABATTOIR
