A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ST. JOACHIM & ANNE'S PHARMACY FOR THE SUPPLY & DELIVERY OF DRUGS & MEDICINES FOR THE NATIONAL TUBERCULOSIS PROGRAM
