A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 189 ENTERPRISES FOR THE SUPPLY AND DELIVERY OF WOMEN EMPOWERING CAMPAIGN T-SHIRT WITH PRINTS

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA 12009 as the mode of procurement for **Purchase Request No. 2025-02-0189** with an Approved Budget for the Contract (ABC) of **Php 441,600.00**;
