A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DISTRICT MUSIC CAFÉ DINER AND CATERING SERVICES FOR THE SUPPLY & DELIVERY OF MEALS FOR THE DIGITAL LITERACY TRAINING PROGRAM OF THE TABACO CITY LIBRARY (4 BATCHES)

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-03-0324** with an Approved Budget for the Contract (ABC) of **Php 259,200.00**.

WHEREAS, the BAC has posted in the PHILGEPS website the Request for Quotation for this procurement and sent to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:
