A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT AND CONSTRUCTION FOR THE JOB ORDER - LABOR & MATERIALS FOR THE INSTALLATION / IMPROVEMENT OF SAN MIGUEL ISLAND WATER SUPPLY SYSTEM AT BRGY. VISITA, SMI, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-03-0353** with an Approved Budget for the Contract (ABC) of **Php 499,966.00** ;
