A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JOUIR GENERAL MERCHANDISE FOR THE SUPPLY AND DELIVERY OF SHOES (PARADE UNIFORM) FOR PALARONG BICOL 2026

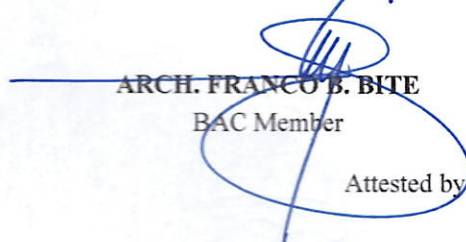
WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;
