**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO SURE8COOL REFRIGERATION AND AIR CONDITIONING SYSTEM TRADING FOR THE SUPPLY, DELIVERY & INSTALLATION OF 2 UNITS AIRCONDITIONER AT 5TH FLR FUNCTION HALL AND 1 UNIT AT 2ND FLR CONFERENCE HALL, CITY HALL**

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-03-0423** with an Approved Budget for the Contract (ABC) of **Php 600,000.00**.

- a.) To award the contract to **Sure8cool Refrigeration and Air Conditioning System Trading** as the Supplier with Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b.) To recommend to the City Mayor of Tabaco the award of contract to **Sure8cool Refrigeration and Air Conditioning System Trading** in the amount of **Five Hundred Ninety Seven Thousand Five Hundred Pesos and One Centavo (Php 597,500.01)**.
