**A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB), AND RECOMMENDING THE AWARD OF CONTRACT TO BMT MARKETING FOR THE SUPPLY AND DELIVERY OF ASSORTED SCHOOL SUPPLIES FOR LIBRENG GAMIT 2025, MAYOR'S OFFICE TABACO CITY, UNDER CONTRACT ID NO. 015-10-2025-GOODS-PB-LIBRENG GAMIT 2025**

**WHEREAS**, the City Government of Tabaco posted the Invitation to Bid for the **SUPPLY AND DELIVERY OF ASSORTED SCHOOL SUPPLIES FOR LIBRENG GAMIT 2025, MAYOR'S OFFICE TABACO CITY, UNDER CONTRACT ID NO. 015-10-2025-GOODS-PB-LIBRENG GAMIT 2025** with an Approved Budget for the Contract (ABC) amounting to **SIX MILLION NINE HUNDRED NINETY-NINE THOUSAND NINE HUNDRED FIFTY-FOUR PESOS AND 00/100 (PHP6,999,954.00)** in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

**WHEREAS**, in response to the said posting, one (1) supplier has shown interest in participating in purchasing the bidding documents;

**WHEREAS**, during the deadline for submission and opening of bids on 27 November 2025, the BAC received one (1) bid proposal;

**WHEREAS**, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

**NOW, THEREFORE**, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of **BMT MARKETING** as the Single Calculated Responsive Bid (SCRB) for the **SUPPLY AND DELIVERY OF ASSORTED SCHOOL SUPPLIES FOR LIBRENG GAMIT 2025, MAYOR'S OFFICE TABACO CITY, UNDER CONTRACT ID NO. 015-10-2025-GOODS-PB-LIBRENG GAMIT 2025**; and
- b) To recommend to the City Mayor of Tabaco the award of contract to BMT MARKETING in the amount of **SIX MILLION NINE HUNDRED FIFTY-THREE THOUSAND SEVEN HUNDRED SEVENTY-FOUR PESOS AND 00/100 (Php6,953,774.00)**.
