A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO BMT MARKETING FOR THE SUPPLY AND DELIVERY OF FOUR (4) UNITS BRAND NEW EMERGENCY/RESCUE VEHICLES, MAYOR'S OFFICE / CDRRMO, TABACO CITY, UNDER CONTRACT ID: CB_GOODS_2026-04-0001

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply and Delivery of Four (4) Units Brand New Emergency/Rescue Vehicles, Mayor's Office / CDRRMO, Tabaco City, under Contract ID: CB_GOODS_2026-04-0001*, with an Approved Budget for the Contract (ABC) amounting to *Ten Million Nine Hundred Thousand Pesos and 00/100 (Php10,900,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on May 11, 2026, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids conducted on May 12, 2026, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare the bid of **BMT MARKETING** as the Single Calculated Responsive Bid (SCRB) for the *Supply and Delivery of Four (4) Units Brand New Emergency/Rescue Vehicles, Mayor's Office / CDRRMO, Tabaco City, under Contract ID: CB_GOODS_2026-04-0001*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to **BMT MARKETING** in the amount of *Ten Million Eight Hundred Ninety-Five Thousand Pesos (Php 10,895,000.00)*.
