**A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO ST. JOACHIM AND ANNE'S PHARMACY FOR THE SUPPLY AND DELIVERY OF DRUGS AND MEDICINES (FOR OB, HYPERTENSIVE PATIENTS AND OUTPATIENT USE), VISITA HACIENDA, SMLIK, TABACO CITY UNDER CONTRACT ID: CB\_GOODS\_2026-04-0003**

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply and Delivery of Drugs and Medicines (for OB, Hypertensive Patients and Outpatient Use), Visita Hacienda, SMLIK, Tabaco City under Contract ID: CB\_GOODS\_2026-04-0003*, with an Approved Budget for the Contract (ABC) amounting to *Four Million Eighty-Nine Thousand Two Hundred Seventy-One Pesos and 60/100 (Php4,089,271.60)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on May 18, 2026, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:




