INVITATION TO BID FOR THE

SUPPLY AND DELIVERY OF MEDICAL LABORATORY SUPPLIES (For CHU Medical Laboratory Supplies), CHU, TABACO CITY

1) The City Government of Tabaco, through the GF-MOOE (CHU 2026) intends to apply the sum of ONE MILLION SEVEN HUNDRED TWENTY-NINE THOUSAND SEVEN HUNDRED NINETY PESOS AND 70/100 (Php1,729,790.70) being the Approved Budget for the Contract (ABC), to payments under the contract for SUPPLY AND DELIVERY OF MEDICAL LABORATORY SUPPLIES (For CHU Medical Laboratory Supplies), CHU, TABACO CITY with Contract ID CB_GOODS_2026-05-0006. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2) The City Government of Tabaco now invites bids for the SUPPLY AND DELIVERY OF MEDICAL LABORATORY SUPPLIES (For CHU Medical Laboratory Supplies), CHU, TABACO CITY. Delivery of the Goods requires thirty (30) calendar days. Bidders should have completed at least 5 years from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as

specified in the IRR of RA No. 12009.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4) Interested Bidders may obtain further information from City Government of Tabaco and inspect the Bidding Documents at the address given below during office hours from Monday to Thursday, 8:00 AM to 5:00 PM.

5) A complete set of Bidding Documents may be acquired by interested Bidders on 19 May 2026 – 11 June 2026 from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos and 00/100 (Php5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity given below, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

6) The City Government of Tabaco will hold a Pre-Bid Conference on 27 May 2026, 1:30 PM at the BAC Conference Room, Mezzanine Floor, City Legal Office, 2F Annex Building, Tabaco City Hall, Tabaco City, which shall be open to prospective Bidders.

7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the office address indicated below, on or before 9:00 AM, 11 June 2026. Late bids shall not be accepted.

8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.

9) Bid opening shall be on 11 June 2026, 9:30 AM at the BAC Conference Room, Mezzanine Floor, City Legal Office, 2F Annex Building, Tabaco City Hall, Tabaco City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

10) The City Government of Tabaco reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
