**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO NUPRINT MASTER FOR THE PRINTING/REPRODUCTION OF ECCD BOOKLETS TO BE DISTRIBUTED TO DIFFERENT CHILD DEVELOPMENT CENTERS FOR THE ASSESSMENT OF CHILDREN'S DEVELOPMENTAL DOMAINS**

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-04-0633** with an Approved Budget for the Contract (ABC) of **Php 250,000.00**;
