A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ST. JOACHIM AND ANNE'S PHARMACY FOR THE SUPPLY & DELIVERY OF MEDICAL DENTAL LABORATORY SUPPLIES FOR MEGA HEALTH CARAVAN

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco adopted Small Value Procurement pursuant to Section 34 of the Implementing Rules and Regulations of Republic Act No. 12009 as the mode of procurement for Purchase Request No. 2026-04-0649, with an Approved Budget for the Contract (ABC) of **Php 900,965.00**;

WHEREAS, the BAC issued Requests for Quotation (RFQs) to bona fide suppliers, specifying the required technical specifications, quantities, ABC, and the applicable terms and conditions of the procurement;

WHEREAS, after the deadline for submission of quotations, the BAC received five (5) price quotations from **Murex Diagnostic Products Specialists, Pharmedics Medical Equipment and Supplies Trading, St. Joachim and Anne's Pharmacy, Choice Drugstore, and B-Sure Pharma and Medical Supplies Distribution**;

WHEREAS, upon opening, preliminary examination, and evaluation of the submitted quotations, the bids of **Murex Diagnostic Products Specialists** was declared non-compliant for failure to quote on all required items, while the quotation submitted by the remaining four (4) Suppliers were found to be complete with evaluation result as follows:

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, **Pharmedics Medical Equipment and Supplies Trading**, it was determined that its bid is non-compliant with the bid requirements for failing to indicate the brand of the offered items. Hence, its bid was disqualified;

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the second lowest quoted price, **St. Joachim & Anne's Pharmacy**, its bid was found to be compliant and responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare **St. Joachim and Anne's Pharmacy** as the supplier with the Lowest Calculated and Responsive Bid (LCRB) for the subject procurement;
- b.) To recommend to the Honorable City Mayor of Tabaco the approval of the award of contract to **St. Joachim and Anne's Pharmacy** in the total amount of Contract Amount in words **Eight Hundred Eighty-Nine Thousand Nine Hundred Sixty-Three Pesos (Php 889,963.00)**;
