A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ST. JOACHIM AND ANNE'S PHARMACY FOR THE SUPPLY AND DELIVERY OF MICRONUTRIENT POWDER FOR THE SUPPLEMENTATION OF 6-59 MONTHS CHILDREN

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA 12009 as the mode of procurement for **Purchase Request No. 2026-04-0651** with an Approved Budget for the Contract (ABC) of **Php 700,000.00**;
