**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO
VICARISH PUBLICATION & TRDG INC FOR THE SUPPLY AND DELIVERY OF SUPPLEMENTARY
LEARNING MATERIALS FOR ACADEMIC RECOVERY AND ACCESSIBLE LEARNING (ARAL) PROGRAM**

WHEREAS, the Bids and Awards Committee (BAC) has adopted **Direct Contracting** as the mode of procurement for the **Supply and Delivery of Supplementary Learning Materials for Academic Recovery and Accessible Learning (ARAL) Program** under Purchase Request No. **2026-04-0672** with an Approved Budget for the Contract (ABC) amounting to **Three Million Six Hundred Fifty-One Thousand Six Hundred Pesos and Thirty-Three Centavos (Php 3,651,600.33)**;

WHEREAS, the BAC directly negotiated the foregoing project with **VICARISH PUBLICATION & TRDG INC** by requesting the same to submit a price quotation or pro-forma invoice together with the terms and conditions of the sale;


WHEREAS, after the deadline for submission of price quotation, **VICARISH PUBLICATION & TRDG INC** has offered to supply and deliver the goods at a contract price of **Three Million Six Hundred Fifty-One Thousand Six Hundred Pesos and Thirty-Three Centavos (Php 3,651,600.33)**;

WHEREAS, upon careful examination, validation, and verification of all the documents submitted by **VICARISH PUBLICATION & TRDG INC** the BAC found that it is technically, legally and financially capable to deliver the goods and the price offered is the most advantageous price for the government;

NOW, THEREFORE, in the light of the foregoing considerations, We, the members of the Bids and Award Committee, hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend for approval by the City Mayor of Tabaco the award of the foregoing contract to **VICARISH PUBLICATION & TRDG INC** at a contract price amounting to **Three Million Six Hundred Fifty-One Thousand Six Hundred Pesos and Thirty-Three Centavos (Php 3,651,600.33)**.
