**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT AND CONSTRUCTION FOR THE JOB ORDER - LABOR, EQUIPMENT RENTAL, AND MATERIALS FOR THE REPAIR/IMPROVEMENT OF CITY GENERAL SERVICES AND PESO AT TABACO CITY HALL, ANNEX BUILDING, QUINALE-CABASAN, TABACO CITY**

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA 12009 as the mode of procurement for **Purchase Request No. 2026-04-0685** with an Approved Budget for the Contract (ABC) of **Php 529,073.72**;

WHEREAS, the BAC has posted in the PHILGEPS website the Request for Quotation for this procurement and sent to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:
